Scott High School is proud to sponsor our first Jr Division Forensics competition at Woodland Middle School on November 22nd here in Taylor Mill, Ky. We invite all middle school teams of Ky and beyond the Bluegrass to join us for our "musically inspired" tournament!

#### Categories

All KHSSL IE Jr categories will be offered. Students may be triple entered, but not be tripled in a single flight. It is not recommended that a student triple in more than two limited prep events, as rounds will not be held up for any student who is behind.

#### **Awards**

We will honor the top 6 speech performers in every category with a trophy, and a "next out" award will be given to the 7th place competitor in each category.

We will honor the top 3 overall teams with Sweepstakes trophies, as well as recognizing the top 3 small schools who have 20 entries or less.

#### Entries

Teams are welcome to enter an unlimited amount of students in each event, provided no student is more than triple entered and not triple entered in any single flight. Only the top 3 students in each event will count towards swepstakes. Each entry will be \$5, with Duo Acting and Duo Improv entries at \$10. The deadline for entries will be November 19th at 4pm.

Drop fees will be assessed and enforced after this time, \$10 per drop.

Only 5 name changes will be assessed at no cost the morning of the tournament—after 5 changes, a \$5 nuisance fee per name change will be assessed.

Checks will need to be made to the order of: Woodland Middle School.

#### **Judges**

One judge for every 6 entries or fraction thereof: 7 entries=2 judges, etc. Larger schools—please try to find neutral judges to bring to the tournament and make sure that they are well versed in the KHSSL rules and ballots. You may hire judges at \$30 each.

A hospitality room will be available for coaches, judges, volunteers, and bus drivers.
